## **New Indigenous Verification Policy Presentation and Consultation**

Highlights from the presentation that was provided included:

- background information
- list of similar policies from other universities
- consultation plan/groups

To begin the consultation, the group was asked the following questions:

- What would you recommend be included in the verification process?
- How do we ensure that spaces for Indigenous people are protected?
- What are the grey areas to be mindful of?

Following a discussion, members were invited to send additional feedback directly to Denise Baxter and/or Roshni Antony for consideration.

#### Advisors Committee Terms of Reference Review - Round Table Discussion

A memo outlining the review process to date, and that included the first draft of proposed revised OIEC Advisors Committee Terms of Reference was circulated with the meeting package. Members were invited to leave feedback directly in the feedback document in advance of the meeting, and had the opportunity to share feedback during the meeting. The following recommendations were made:

- In addition to the Vice-Provost's portfolio, consider including other portfolios to the membership, such as External Relations and Administration and Finance (e.g. residence, security, etc also support students).
- Consider adding student(s) to the membership.
- Given the scope of internal topics primarily related to academics and student services, would it be more appropriate for the committee to be advisory to the Provost? The Vice-Provost, Indigenous Initiatives also reports to the Provost directly, so this might be more expedient.

Deadline to submit feedback is October 18, 2023.

## Nanabijou Child Care Centre - Round Table Discussion

The following concerns with regards to daycare needs of Lakehead students at the Nanabijou Child Care Centre were brought the the group's attention:

- there is a child care crisis at Lakehead
- it was reported by the Indigenous Student Counsellor Indigenous Student Services
  Centre, that there are six students planning to leave their programs this week because of
  childcare issues
- LUSU has a legal agreement with the centre students pay an annual fee that goes directly
  to the child care centre, yet the services don't seem to be available to Lakehead students
- hours of operation are traditional and don't align with students schedules
- the Indigenous Student Counsellor Indigenous Student Services Centre, has made multiple attempts to connect with center to request information on child care enrollment numbers related to Lakehead students
- the Indigenous Student Counsellor Indigenous Stu
