The following pattern of courses indicates the compulsory and elective courses leading to the Honours Bachelor of Social Work (HBSW) degree. The courses listed below with course numbers are compulsory for the degree. If a student wishes to take courses other than those listed below, he/she must obtain the consent of the Director of the School. All elective courses must be taken in consultation with the School.

First Year:

- (a) Social Work 1100
- (b) Four FCE electives (Social Work, and courses crosscalendared with Social Work, excluded)

Note:

Students are encouraged to select the four FCE electives, excluding Social Work and courses cross-calendared with Social Work, from the Faculty of Social Sciences and Humanities; however, electives may be taken from any Faculty. A maximum of seven (7) first year FCEs may be taken.

Students are advised that they must apply for admission to Year 3. Since application does not guarantee admission, students may be admitted to an alternate program. Bearing this in mind, students should consider requirements for other programs when selecting elective courses. Students with more than 14.5 FCEs are not eligible to apply to Year 3

Pedagogical rationale for In the fall of 2022, we replaced a required course: INDI this proposal. Why are you 3501 (1.0FCE) with INDI 2012 (0.5FCE).Rational for this submitting this request?: change: • Students currently entering INDI 3501 do not have the disciplinary background and the first half of the course is spent teaching introductory materials that should have been introduced in a second year course. Thus, the shift of

INDI 3501 to a second year course is done in order to provide the students with the necessary scaffolding to undertake a more senior level course (4th year) in this area. • Indigenous Learning also has a significant number of required FCEs (3.5/3yr BA & 4.5 4/yr HBA) and this is part of a broader curriculum revision that seeks to reduce the number of required FCEs for students and develop more scaffolding and preparatory work at the lower level so that students are better prepared to take on capstone projects in their fourth year classes. Unfortunately, we did not make the program specific changes in the calendar at the same time. Thus, this navigator change is to fix these problems. As a result of the changes we needed to fix the number of FCEs taken at the third year level and shift a required course from the third to the second year level. Additional Rationale for Honours Bachelor of Social Work with Concentration in Indigenous Learning changes: We replaced INDI 3501 (1FCE) with INDI 2012 (0.5 FCE) and the option of taking one of the following courses: INDI 3232: Indigenous People and Self-Determination, INDI 3315: Mino-Bimaadiziwin, and INDI 3613: Ogichi Daa Kwe: Indigenous Women's Resistance and Resurgence. We also deleted INDI 1310: Methods/Approaches Applied to Indigenous Learning at the first year. We added an elective in Indigenous Learning at the fourth year level course. We made these changes because Social Work students need to have a fuller understanding of systemic challenges/issues facing Indigenous communities as well as an appreciation of Indigenous worldviews/culture. These changes also allow students more choice in their course selection to better reflect their interests and support professional development. We have discontinued 3215 and 3315 and have merged them into 1 FCE: SOWK 3100
