Pedagogical rationale for this proposal. Why are you submitting this request?:

In With the last revision of the degree, starting Sept. 2022, students are required to complete a "core disciplinary course" within at least one of their disciplines. The list of eligible courses was incomplete as it did not include at least one course for each discipline. The new list includes at least one course for each discipline. Additionally, courses on this list were previously restricted to 2nd year "methodological" courses. This restriction was dropped starting 2022-23 and as a consequence contributing departments were invited to revise the course(s) they contribute to this list. English recommended different courses, which appear on the revised listretirement of an Orillia faulty member in Political Science who contributed to the concentration, we would like to deemphasize the politics element of the concentration and rename the concentration Environment, Society, and Culture. Parallel name changes will be made to the corresponding INTD courses that support the concentration. These courses, Interdisciplinary Studies 1013, 3013 and 4013 have a strong social component. The social dimension is prominent in the calendar course descriptions and in the topics covered in the 3013 and 4013 courses. Interdisciplinary Studies 4013 is regularly cross-listed with Social Justice Studies 5011 as "Environmental Justice." There are also many courses related to society and the environment now on the concentration list, many added since the concentration was first created as more courses are being offered at the Orillia campus. These include History 3718, which examines the historical

relationship between human societies and the natural environment; Gender and Women's Studies 2114 Ecofeminism; Sociology 2110 Food, Culture and Society; and Sociology 2113 Environmental Society; as well as the previously included courses in Criminology and Media, Film and Communications that have a social dimension. Hence, the decision was made to change "politics" to "society". Also we are adding Philosophy 2013 Environmental Philosophy, Philosophy 3418 Social and Political Philosophy II and History 4713 Imperialism and Environment to the concentration list. These courses are relevant to the concentration and will be regularly available to Orillia students in the future. Finally we are removing WOME 3118 from the concentration course list as it no longer exists.

There are two changes to this degree. The first is the addition of Philosophy as a discipline that students might choose to study. The second is revisions to the list of core disciplinary courses. In the last revision of the degree, starting Sept. 2022, students are required to complete a "core disciplinary course" within at least one of their disciplines. The list of eligible courses was incomplete as it did not include at least one course for each discipline. The new list includes at least one course for each discipline. Additionally, courses on this list were previously restricted to 2nd year "methodological" courses. This restriction was dropped starting 2022-23 and as a consequence contributing departments were invited to revise the course(s) they contribute to this list. Several departments recommended different or additional courses, which appear on the revised listWith the retirement of an Orillia faulty member in Political Science who contributed to the concentration, we would like to deemphasize the politics element of the concentration and rename the

concentration Environment, Society, and Culture. Parallel name changes will be made to the corresponding INTD courses that support the concentration. These courses, Interdisciplinary Studies 1013, 3013 and 4013 have a strong social component. The social dimension is prominent in the calendar course descriptions and in the topics covered in the 3013 and 4013 courses. Interdisciplinary Studies 4013 is regularly cross-listed with Social Justice Studies 5011 as "Environmental Justice." There are also many courses related to society and the environment now on the concentration list, many added since the concentration was first created as more courses are being offered at the Orillia campus. These include History 3718, which examines the historical relationship between human societies and the natural environment; Gender and Women's Studies 2114 Ecofeminism; Sociology 2110 Food, Culture and Society; and Sociology 2113 Environmental Society; as well as the previously included courses in Criminology and Media, Film and Communications that have a social dimension. Hence, the decision was made to change "politics" to "society". Also we are adding Philosophy 2013 Environmental Philosophy, Philosophy 3418 Social and Political Philosophy II and History 4713 Imperialism and Environment to the concentration list. These courses are relevant to the concentration and will be regularly available to Orillia students in the future. Finally we are removing WOME 3118 from the concentration course list as it no longer exists.
